
OVERVIEW

Pin Rail - Working Load Limits (WLL)



These Working Load Limits should never be exceeded and if they are the unit must be retired immediately.

The Pin Rail is not designed for side loading. The engineering is only valid for direct upwards pulling.

The Pin Rail must only be installed on a suitable thickness and grade concrete slab. Please contact the structural engineer of your building or studio for their requirements.

General Notes: Risk and Responsibility

- Every person assisting with set up or use of the pin rail must be familiar with this guide and instructed on proper installation.
- Trix Circus is not responsible for any direct, indirect or accidental consequences or damage stemming from the use of the equipment.
- All components of the pin rail have been engineered specifically for the system by Ken Brown and Associates. No components shall be substituted for any other or altered. Any substitution will void the engineering calculations and the pin rail will no longer be compliant to the engineer's designs. TRIX AERIAL RESCUE AND ANCHORAGE PIN RAIL

TYING OFF GUIDE



1. Lay the rope infront of the rail & behind the bottom pin.



2. Begin a figure eight.



3. Complete the figure eight.



4. Make a half hitch.



5. Put the half hitch on the top pin & pull tight.



6. Begin another figure eight.



7. Add another half hitch on the top pin & pull tight.



8. Add a second half hitch on the top pin.



9. Pull tight & make sure your tie off is secure.
